## **EXAMPLES OF TAX WITHHOLDING METHODOLOGY**

In this example, the employees' contract pay amount is \$6200.01 (biweekly of \$688.89), the contract periods are 9, the marital status is single, and the employee has filed one withholding allowance.

1. Federal Taxes - the annual Federal amount per allowance is \$2,900.
